Title: Physician on Scene

Standard: Patient Care and Transport

Policy: HEMT/SMFD providers may allow patient care to be directed by an on-

scene physician under specific and approved circumstances.

I. Purpose

To explain the circumstances under which a physician on an emergency scene may direct patient care.

II. <u>Definitions</u>

- A. <u>Personal Physician</u>: is a physician who has previously established a doctor-patient relationship with the patient. This does not include a physician who is acting as a coach, trainer, or participant in a patient's athletic program.
- B. <u>Intervener Physician</u>: is a physician unknown to the patient who presents at the scene with the intent to provide care to the patient.

III. Procedure

- A. HEMT Clinicians must do the following:
 - 1) Introduce themselves to the physician on scene..
 - 2) Request proof of the physician's identity and Minnesota medical license.

Patient's Personal Physician On-Scene

- A. Verify that physician is the patient's Personal Physician..
- B. Follow any orders provided by the physician to the extent that the orders are in compliance with HEMT Patient Care Guidelines.
- C. In the event of a disagreement between the Personal Physician and HEMT/SMFD providers;
 - 1. Contact HEMT Medical Control and request they speak directly to the Personal Physician.
 - 2. If any disagreement persists between the Personal Physician and Medical Control the Personal Physician must either;
 - a) Continue to provide direct patient care AND accompany patient to the hospital.
 - b) Defer all care to the on-scene HEMT/SMFD providers and Medical Control.

Intervener Physician On-Scene

- A. Provide the Intervener Physician with a copy of the On Scene Physician card.
- B. If Intervener Physician agrees to the requirement list on the On Scene Physician card contact HEMT Medical Control. Medical Control has the option to;
 - 1. Request that HEMT/SMFD providers maintain exclusive control of patient care.
 - 2. Approve the assistance of the Intervener Physician with patient care.
 - 3. Allow the Intervener Physician to assume complete responsibility for the patient.
 - 4. The Intervener Physician may, with agreement of HEMT Medical Control, be allowed to not accompany the patient to the hospital in the ambulance.

IV. Documentation

- A. Document the identification of any on-scene physician that participates in patient care.
- B. Document the delivery of the Medical Miranda Card to the Intervener Physician.
- C. Document all contacts with HEMT Medical Control.

V. Special Notes

A. Medical Miranda Card (stored in ambulance clipboard)

To serve as an on-scene medical control physician, you must agree to all of the following:

- · Provide evidence that you are a licensed MD or DO in Minnesota:
- · Obtain permission from the Medical Control Physician to assume responsibility for this patient;
- · Have the skills and knowledge to manage an emergency
- · Agree to accompany the patient to the hospital in the ambulance, and
- Sign the Patient Care Report after patient care is complete.

If you cannot fulfill all of these requirements, please allow the EMS providers to treat this patient without interference.
